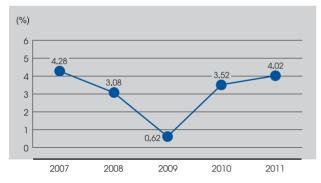
With regard to the basic policy, the Company set dividend and share-buyback as methods for distribution to shareholders.

The company intends to achieve "the rate of total distribution on net assets*" at approximately 4% each year from fiscal year ending on Mar. 31st 2008 to fiscal year ending on Mar. 31st 2013. The Company also intends to retire its own shares which will be repurchased in future according to this basic policy.

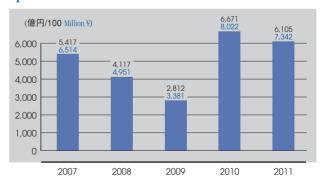

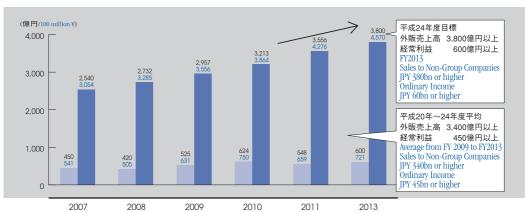
