We hereby announce that, at legal separation of the general transmission and distribution businesses which we have discussed, we determined the fundamental matters concerning company split and the establishment of a split preparation company as a specific procedure for company split today.

1. Fundamental matters concerning company split

(1) Company form after company split

In order to ensure further neutrality of general transmission and distribution businesses, we will split general transmission and distribution businesses, and establish a wholly-owned company (referred to as the "Transmission and Distribution Company") under the holding company operating electric power generation and retailing businesses.

(2) Type of company split

This is an absorption-type split where our company is a splitting company and Transmission and Distribution Company is a succeeding company.
