It was decided at the extraordinary meeting of the board of directors held today that a third-party committee consisting of only neutral and unbiased members independent of the company is to be established as follows.

The third-party committee shall be established and operated in compliance with "thirdparty committee guidelines regarding to scandals of corporation and any other organizations." of the Japan Federation of Bar Associations.

Along with conducting an objective and thorough investigation, the third-party committee is expected to find the cause of the problems, discuss how to prevent reoccurrence and report those findings to us. We will announce the results as soon as possible.

We offer our most sincere apologies for the inconveniences and concern placed upon our customers and other parties including those of the local communities.

We will address the findings of the third-party committee in a serious manner and do whatever it takes to ensure it does not reoccur.
